1. Information We Collect

a. Personal Information You Provide Voluntarily

b. Automatically Collected Data

We do **not** use your information for profiling or automated decision-making.

3. Sharing Your Information

We do not sell or rent your personal data. We may share your information with:

- Trusted service providers (e.g., email platforms, web analytics) under confidentiality agreements
- Legal or government authorities when required by law
- Third parties if necessary to protect our rights or users' safety

These parties are only given access to the data they need to perform their functions.

4. Cookies and Analytics

We use **cookies** to:

- Understand how users engage with our website
- Improve usability and performance
- Track marketing effectiveness

You can manage or disable cookies in your browser settings. Our site may use tools like **Google Analytics**, which collect anonymized traffic data. For details, visit [Google's Privacy Policy](#).
